

2009 Property Tax Rates in BANDERA COUNTY

This notice concerns 2009 property tax rates for BANDERA COUNTY . It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's *effective* tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's *rollback* tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.

A county that collects the additional sales tax to reduce property taxes, including one that collects the tax for the first time this year, must insert the following lines:

- Sales tax adjustment rate	0.032952/\$100

Statement of Increase/Decrease

If BANDERA COUNTY adopts a 2009 tax rate equal to the effective tax rate of 0.662183 per \$100 of value, taxes would increase compared to 2008 taxes by \$ 279,200.

Schedule C - Expected Revenue from Additional Sales Tax

(For hospital districts, cities and counties with additional sales tax to reduce property taxes)

In calculating its effective and rollback tax rates, the unit estimated that it will receive \$ 915,488 in additional sales and use tax revenues. **For County:** The county has excluded any amount that is or will be distributed for economic development grants from this amount of expected sales tax revenue.

Schedule D - State Criminal Justice Mandate (For Counties)

The Bandera Tax County Auditor certifies that Bandera Tax County has spent \$ 0 in the previous 12 months beginning 10/01/2008, for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. Bandera Tax County Sheriff has provided information on these costs, minus the state revenues received for reimbursement of such costs.
