BANDERA COUNTY, TEXAS


WHEREAS, to promote public safety, the commissioners court of Bandera County finds it necessary to regulate the discharge of firearms on lots that are 10 acres or smaller and located in the unincorporated areas of the county in a subdivision.


THEREFORE, it is hereby ordered that the discharge of firearms on lots that are 10 acres or smaller in the unincorporated areas of the county in a subdivision is prohibited.


THEREFORE, it is further ordered that any person who violates a provision of this Section shall be guilty of a Class C Misdemeanor.

EFFECTIVE this the 27 day of January, 2000.






WHEREAS, Section 240.042 of the Local Government Code permits the commissioners court of a county by order to prohibit or otherwise regulate hunting with bows and arrows on lots that are 10 acres or smaller and are located in the unincorporated area of the county in a subdivision.


WHEREAS, hunting with bows and arrows threatens the public safety in lots 10 acres or smaller has become a serious problem in Bandera County, threatening the health and safety of the citizens of Bandera County, Texas.


THEREFORE, BE IT RESOLVED, that the Bandera County Commissioner's Court enter an order as attached hereto as *Exhibit "A"* prohibiting hunting with bows and arrows on certain lots in a subdivision in Bandera County, Texas and replacing any and all prior orders of the Bandera County Commissioners Court relating to hunting with bows and arrows.
