	\$100.00 (day use w/electric usage) plus any required deposits, includes Use of a PA System and One Concession hookup, plus an additional \$20.00 for each Concession hookup requested.
	\$150.00 (day & night w/ electric and lights) plus any required deposits includes use of a PA System and One Concession hookup, plus \$20.00 for each additional Concession hookup requested.
Water Rodeo Arena	\$20.00 (each time)
Drag Rodeo Arena (county employee)	\$25.00 (one time during normal business hours)
Rec. Hall (has air/heat capability)	\$175.00 (plus any required deposits) \$50.00 to receive access from 3:00PM day before event.
Pole Barn	\$50.00 (plus any required deposits) has water and electric.
Front Pavilion/Bar room/Gazebo	\$ NOT AVAILABLE at this time
Front Pavilion BBQ Grills	\$40.00 (+\$30.00 deposit)
RV Park Pavilion (has electric& water)	\$60.00 (plus any required deposits)

ADDITIONAL INFO:

28 RV Spaces---unlimited Tent Spaces ---- Grand Stands 3,000 max—Cattle Pens approx 300 head – 35 Concession Stand Hookups

- All fees must be paid before receiving access to the facility. Access is granted only for the day it has been rented for. Should set-up or decorations for the event be needed prior to the day the facility is rented, you will be charged an additional amount.
- Any area rented **MUST** be left clean and damage free. If renter cleans, removes trash, and there is no damage, maint/damage deposit will be refunded. County personnel will evaluate rented area after vacated. There is a \$5.00 charge for each bag of trash removed by county personnel, which will be deducted from the maint. /damage deposit.
- Deposit for the PA system will be refunded after the event is over and county personnel have verified the PA system is in good working order.
- Maximum stay in RV/Tent spaces will be 7 days.
- Livestock will not be allowed in RV/Tent area, to free range, be tied to fences or allowed on athletic fields.
- **ALL** pets must be confined, leashed, or tethered at **ALL** times.
- No park property will be removed from premises.
