CONSTITUTIONAL AMENDMENT ELECTION

Rebekah "Reba" Dolphus, PCC, CTOP, Tax Assessor-Collector, reported out of 19,019 registered voters in the county 24.40% or 4,831 voters voted in the November 7, 2023, Constitutional Amendment Election. Commissioners' Court canvassed the votes for all election precincts ballots.

Comm. Rutherford moved to certify the election returns of the November 7, 2023, Constitutional Amendment Election pursuant to Texas Election Code, Section 67.003, subject to clerical corrections by the precinct election judges.


