## **Bandera ISD: Board of Trustees**

NOTE: School board elections are nonpartisan. Candidates do not declare a political party preference.

Check your yellow voter registration card to determine if you are eligible to vote in this election – see the boxes on the right hand side of the card. Or consult the State of Texas website: <u>votetexas.gov</u> and follow instructions to check the information on your voter registration card online.

Some voters in Precinct 101, Precinct 102, Precinct 203, Precinct 204, Precinct 305, Precinct 407, Precinct 408, and Precinct 409 are eligible to vote in this election.

The Bandera ISD Board of Trustees consists of seven members with each member elected to serve a three-year term. Candidates run for a numbered place on the school board, but they do not represent a specific geographical area. Each board member represents the entire school district. Elections are held annually in November.

Duties: adopting policy, employing and evaluating the superintendent, approving the budget, approving capital improvement plans, and setting the tax rate.

#### What in your background qualifies you to serve on the Bandera ISD School Board?

**Black:** I played an integral role in the Bandera Independent School District Vision and Core Value Committee. I am an informed citizen of Bandera County and regularly attend the Bandera Independent School District School Board Meetings. In addition, I served on the Bandera ISD Community Action Committee. I fully support our schools and have happily volunteered at the School Campuses: Hill Country Elementary School, Bandera Middle School and Bandera High School.

**Martinez:** I've worn nearly every hat in a school - teacher, counselor, coach, bus driver, receptionist, and substitute. With 15 years in education, I've taught science, English, dance, PE, and worked in special education as both teacher and case manager. These experiences give me a true, ground-level view of what students, teachers, and staff need to succeed. I also hold an MBA from Texas A&M Kingsville and a Master's in Counseling and Development from Lamar University. I'm ready to bring both real-world classroom experience and strong leadership skills to the Bandera ISD school board.

**McCarthy:** No response received by print deadline.

#### What are the most pressing issues facing the BISD School Board?

**Black:** The most pressing issues facing the BISD School include Faculty and Staff retention, Budget Management, Security and Safety of all campuses. These are some of the same issues that other School Districts face statewide. Our Bandera ISD School Board continues to effectively navigate our District through the new state laws affecting current curriculum, budget and school operations.

**Martinez:** The most pressing issues facing BISD are student achievement, teacher support, and fiscal responsibility. We must ensure all students are prepared for success by providing strong academics along with social and emotional support. At the same time, we must recruit and retain quality teachers by valuing their work and creating an environment where they can thrive. Finally, we must be responsible stewards of taxpayer dollars, balancing the district's budget while making sure resources reach classrooms first. Together, these priorities strengthen our schools and community.

McCarthy: No response received by print deadline.

#### What are citizens and parents telling you about school district issues?

**Black:** Citizens and parents have voiced their strong opinions concerning safety and communication. I plan to listen to all concerns and am willing to find solutions that are most fitting for the issue being addressed. Overall, the message is clear: our community values strong schools, safety, responsible leadership, and a board that truly listens to parents, teachers, and taxpayers.

**Martinez:** Parents and citizens tell me they want schools that put students first—academically, socially, and emotionally. They are concerned about retaining quality teachers and making sure classrooms have the resources they need. Families want transparency in decision-making, open communication from the district, and safe campuses where students can learn without fear. Many also emphasize the importance of preparing students for life after graduation, whether college, career, or military service. Overall, the message is clear: our community values strong schools, safety, responsible leadership, and a board that truly listens to parents, teachers, and taxpayers.

## City of Bandera: City Council

NOTE: City elections are nonpartisan. Candidates do not declare a political party preference.

Some voters who live in <u>Precinct 305</u> are eligible to vote in this election. Bandera is a general law city (Type A) with a city council/manager form of government. There are five positions on the city council, and each member is elected at large. The term of office is two years.

Duties: appoint the city manager; oversee the city manager and the direction of the city; approve the city budget and the tax rate; set salaries and benefits of city employees; pass ordinances and resolutions; appoint members to advisory boards.

The election is for three at-large positions on the Bandera City Council. The three candidates with the highest number of votes will be declared as elected.

#### What in your background qualifies you to serve as a member of the Bandera City Council?

**Battle:** I've proudly called Bandera home since age six and have lived here for 25 years. Though not born here, I consider myself a true member of this community. I've served six years on the Planning and Zoning Commission and three on City Council. My experience, transparency, and leadership have helped improve public safety with 24/7 patrols, added police cruisers, enhanced water reliability, and secured millions in grant funding. I'm committed to addressing the tough issues and continuing to serve Bandera with dedication and integrity.

**Breen:** Currently: I have been on City Council 2 years. I have also served as Treasurer for 1 year on the Bandera EDC. Volunteer for Bandera Business Association and the Bandera Chamber of Commerce, member of the Music Friendly Texas Board. Previous: BISD Boosters Club, Boys & Girls Club Board Member; helped bring Boys and Girls Club to Hill Country Elementary, ran Chili and Cajun Cookoffs. Lakehills Library Board Member, President; St. Victor's Church Board Member, President; help organize/work Mardi Gras parades; MLVFD volunteer for annual BBQ; Frontier Times Museum volunteer for Labor Day Pro Rodeo events.

**Coffey: Council Project committee chair** of 2 waste treatment plants, new city hall, new senior center, new library, a community center, a community pool, new high school, new fire department, police department and a FEMA emergency center facility, second middle school, family relief center, and a city sponsored fund for non-profit grants. **Council representative** with various county tourism projects, water sources, state committees regarding federal initiatives with immigration work visas and federal/state prison training programs with the trade unions. Inmate earnings placed in a release fund, after release support, family reunification and counseling. All projects exceeded expectations from the state requirements.

**Hicks:** Since 1951, my family has called Bandera home. My passion for our community motivated me to return to Bandera after college with my wife to raise our 3 children in a place where we are committed to its future. Whether I am serving on an advisory board for my family's tourism business or volunteering as a coach for my children's youth sports teams, I have a multifaceted knowledge of what's important to Bandera citizens. I have demonstrated Conservative Christian leadership on the council for the past two years.

McCabe: No response received by print deadline.

**Morrow:** My personal experience qualifies me to serve as a member of the Bandera City Council. As a 30+ year resident of the city, I am invested in the community. Our small family construction business and my community service background has taught me the importance of listening, fiscal responsibility, and practical decision making. I understand the concerns that the citizens face daily in Bandera. I am committed to bringing transparency, accountability, leadership, and respect to my neighbors.

**Teich:** No response received by print deadline.

#### What are the most pressing issues facing the Bandera City Council?

**Battle:** This election is pivotal for Bandera. Over the past three years, I've worked to secure land and funding for a much-needed wastewater treatment plant—critical for our future. My experience with large infrastructure projects helps ensure this is done without burdening taxpayers. I'm also working with TxDOT to improve Main Street while preserving parking in the historic district. With the right leadership, we can enhance walkability and maintain convenience through the continued pursuit of Transportation Alternatives grant funding. I remain committed to practical solutions that serve all of Bandera.

**Breen: Infrastructure:** Our biggest issue. We need a new Waste Water Treatment Plant, new roads, new water and sewer pipes...and not enough money to make these changes. **Grant Money:** We are reliant on grants to make changes and in my opinion, not near enough emphasis is placed on applying for grants by the City. **Reputation of City Council:** Another huge increasing trend that I have seen happening since I started on Council is how little information actually gets to Council. Many important issues are being decided outside of Council. Who is really running the City?

**Coffey:** Lack of teamwork, failure to respect community opinions, disrespectfulness shown to the public, using the council for personal issues and gains. Failure to follow required procedures, such as Robert's Rules of Order, using staff inappropriately to intimidate residents. Failure to secure adequate funding for the new sewer treatment plant, utilizing staff in positions they are not qualified for and failing to provide adequate training for their success. Attempting to remodel downtown which would eliminate significant parking, block businesses with construction and develop us like Boerne. **DON'T BOERNE OUR BANDERA!** We can do better and be better!

**Hicks:** The most pressing issue facing the Bandera City Council is addressing our citizens' concerns and needs while balancing the annual city budget. For example, the city council needs to focus on improving and maintaining our infrastructure, such as roads and water supply while also considering tax rates and the current economic environment. Our businesses need additional tourism and tax dollars to continue providing for the community. We have to continue finding grants to solve our city issues instead of putting that burden on our citizens.

**McCabe:** No response received by print deadline.

**Morrow:** The most pressing issue facing the Bandera City Council right now is rebuilding trust between the city and its residents. Neighbors want to understand how decisions are made, where their money is going and how the council's decisions will improve their day-to-day lives. If we do not fix the breakdown in trust, it will be difficult to fix anything else – whether it be water quality, infrastructure, or managing growth. We need to have open dialogue with our neighbors.

**Teich:** No response received by print deadline.

#### What are the citizens in the City of Bandera telling you about city issues?

**Battle:** As a councilmember, listening to citizens is my top priority. Over the past 3 years, many have expressed a strong desire to preserve Bandera's identity as the Cowboy Capital of the World—a legacy built by our ancestors. My commitment remains strong: protect our heritage, support conservative leadership with integrity, ensure reliable infrastructure, and promote a safe environment for families. I'd be honored to earn your support for another term, continuing to advance these vital priorities for our community.

**Breen:** I have been going door to door and talking with the voters in Bandera. They have been very vocal on the following subjects: **Infrastructure** - Citizens want their infrastructure to be fixed and/or replaced. They want roads without potholes. **Accountability** – they want the City to make budget cuts instead of constantly raising taxes and utilities. **Transparency** – they want to know what is going on in City Hall. **Friendliness** – they feel that City Hall is a hostile environment, and they are not welcome.

**Coffey:** They are tired of the limitless Airbnb's in personal homes. Potholes ignored making the streets unsafe for walkers and bike riders. People moved here for the laid-back easy-going cowboy country mentality, good music from their patios and an overall safe community. They don't want the downtown changed **AT ALL**. I suggested alarmed crosswalks and a half way crosswalk for the 3 major blocks down town to protect pedestrians. Which was received well. They want fewer restrictions on what they can do with their property ownership. Ordinances reduced significantly, a more user-friendly city hall, a community pool and a dog park.

**Hicks:** Citizens are worried that the continued and inevitable growth here will change Bandera. We live in a unique community with rich history that I vow to protect. I have lived my whole life here and want Bandera to be its best version while staying true to our roots. Our citizens are also concerned with rising costs in everyday life especially those on fixed incomes. As a council, we need to be mindful of this challenge while also balancing the needs of the city as a whole.

**McCabe:** No response received by print deadline.

**Morrow:** The citizens of Bandera are frustrated about the rising utility rates and taxes. Since many of our residents are on fixed income, they want to know where their money is going and that it is being used responsibly. They are seeing a rise in utility rates and taxes, but they are not seeing a real improvement in city services. They want transparency, accountability, and assurance that city leadership is managing resources responsibly and working in the best interest of the community.

**Teich:** No response received by print deadline.
